The problem that we have right now is that we are at the end of the line. A budget is going to pass with or without us.

New York has had four (4) different plans and they are not working.

We need to make a lot of noise at this point. They are going before City Council next week. We love this new SRC they are on a train and they are going to go off the cliff.
