Presented on Picture Day and Cherrydale. Used a new vendor Show Stoppers.

Cherrydale is not a big fundraiser because the quality of items is not good. Picture Day shows promise. Better quality of the product. Was push back because the district has a contract with Lifetouch. School Production. Spring Fair - They are also holding two new fundraisers this year - Dance-A-Thon (similar to Penn State Thon) Family Fit Run - catered towards children and talking about fitness. Pulling in small businesses from the neighborhood. Lollipop sales held on ½ day - selling them for \$.50 has brought in about \$1500 in past years. Order only mystery flavors.

#### Alyssa B. (Cook-Wissahickon):

Presented Dress Down Day (N.U.T. - No Uniform Today) pay \$1 every Friday to dress down. Set up Paypal options for parents to pay ahead - this is actually working with parents paying \$37 for full year of dress down options. So far has raised \$5400.
